SAPAGKAT: mababawasan ang bilang ng mga gumagamit ng droga sa pamayanan.

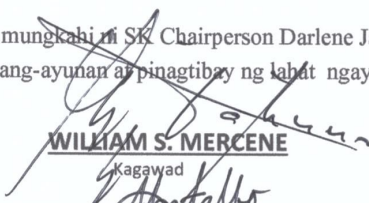
